**Motion** was made by Steve Dolin to approve Net Pay Account Distribution Report, seconded by Jim Beck; motion carried.


**Motion** was made by Marvin Mathiowetz to approve Claims List for Approval Report, seconded by Jim Beck; motion carried.


**Motion** was made by Jim Beck to adjourn meeting at 8:28 p.m., seconded by Marvin Mathiowetz; motion carried.
