**Motion** was made by Steve Dolin to approve Claims List for Approval Report, seconded by Marvin Mathiowetz; motion carried.


**Motion** was made by Jim Beck to adjourn meeting at 8:07 p.m., seconded by Steve Dolin; motion carried.
