- Dave Cottew, Wild Run Addition resident came to meeting to discuss if Greenbush can get an Alarm system which alerts everyone of severe weather conditions. Jim Beck to contact the County to see if a system can be put up in Greenbush Township.
- Steve Dolin received a phone call from Harmon Luedke about a dispute with his neighbor's dog that is digging in his field. Steve to advise Harmon to contact the Sheriff, as this is a civil issue between the residences.

ROAD REPORT

- **2015 Gravel Update** – Currently have 1500 yards of Class 5 remaining of Township's supply. West Branch may start crushing gravel in August, so Greenbush should advise by next month if we want to stockpile for next year.
