Motion was made by Marvin Mathiowetz to approve Net Pay Account Distribution Report, seconded by Steve Dolin; motion carried.


Motion was made by Jim Beck to approve Claims List for Approval Report, seconded by Marvin Mathiowetz; motion carried.


Motion was made by Steve Dolin to adjourn meeting at 8:25 p.m., seconded by Jim Beck; motion carried.
