PUBLIC FORUM

- Jan Jude is running for County Attorney and wanted to attend this month's meeting to answer any questions our Township may have. She has 28 years in the legal field, with most of those years being in Mille Lacs County. She shared some of the issues that she would work on if elected in November.
- Bev Roxbury attended this month's meeting to request Speed Limit Signs to be put up on Dean Drive/Drew Avenue/Linders Road; due to high speed issues taking place.
 - Scot to check with township attorney if speed limit signs are allowed in a residential subdivision, where not currently posted and what is the lowest speed limit township can post.

SHERIFF REPORT

- Deputy Sheriff Tony Erholtz attended this month's meeting.
- There were 46 service calls in Greenbush Township from August 1 through September 25, 2018
- Township Board received a complaint on resident removing gravel on township road. Tony will contact this resident and advised him, that he has been seen removing Class 5 from 55th Street; and this action is against the law and should be stopped immediately.
